On June 5, 2024, Lendingkart Finance Limited ("Company/LFL") surpassed the prescribed threshold (outstanding principal of listed debt securities) of Rupees Five Hundred Crore. Accordingly, LFL was in the process of complying with the applicable provision of Regulations 15 to 27.

However, as per the SEBI circular dated March 27, 2025, the threshold for outstanding listed non-convertible debt securities to qualify as a High Value Debt Listed Entity has been revised to Rupees One Thousand Crore.

LFL does not hold outstanding listed non-convertible debt securities amounting to Rupees One Thousand Crore or more as of March 31, 2025 or as on the effective date of enclosed circular dated March 27, 2025 and will not be classified as High Value Debt Listed Entity.
